Where such information has been announced, below is an update on mandatory mask orders for areas that require masks be worn inside enclosed public spaces such as convenience stores and gas station kiosks.

Please note that this is intended as general guidance and not legal advice. Local by-laws may impose more stringent requirements (e.g. an obligation to provide hand sanitizer and/or an obligation to turn away customers who are not wearing masks). Consult the [CICC website](#) or contact your local public health authority for further information.

ONTARIO

Announced on October 2nd, masks will be mandatory in indoor spaces and on public transit in Ontario throughout the province starting October 3rd under the Reopening Ontario Act.

Under the Reopening Ontario Act, all businesses and organizations require the use of face coverings indoors, with exemptions (listed below). Under the previous order face coverings were only required in commercial establishments.

Individuals working behind a plexiglass or glass barrier are no longer exempt from wearing a face covering, unless the area is not accessible to the public and a 2-metre distance can be maintained from others.

Exemptions to wearing a mask in a convenience store include:

- Individuals under 2 years of age.
- Individuals receiving services that require the removal of their face covering (including for age verification purposes)
- Individuals consuming food or drink.
- Individuals that have medical conditions that inhibit their ability to wear a mask or face covering.
- Individuals that are unable to put on or remove their mask or face covering without the assistance of another person.
- Individuals being accommodated in accordance with the Accessibility for Ontarians with Disabilities Act, 2005.
- Individuals being accommodated in accordance with the Human Rights Code.
- Individuals performing work for the business or organization, in an area that is not accessible to members of the public and are able to maintain a physical distance of at least two metres from others while in the indoor area.

The new regulation expressly states that a person is not required to provide evidence to demonstrate that they fall within one of the exceptions.

Visible signage showing that face masks are required.

Store staff are required to give a verbal reminder that face masks are required.

Retailers still to comply with sale of age-restricted products requirements.

Fines

- An individual is subject to a fine of not more than \$100,000 and for a term of imprisonment of not more than one year;
- An individual who is an officer or director of a corporation is subject to a fine of not more than \$500,000 and for a term of imprisonment of not more than one year, and
- A corporation is subject to a fine of not more than \$10,000,000.

While local by-laws created before the Reopening Ontario Act may remain in effect, local enforcement teams will also enforce the stricter requirements made under the Reopening Ontario Act. As such, this document will continue to share the previously created local by-laws.

BRAMPTON

Effective July 10th

Requirements:

- Create a policy to ensure no customer or visitor is permitted to enter without a mask; this policy must be provided to an inspector or officer upon request
- Communicate policy to staff and customers
- Train staff on the policy and who is exempt
- Ensure that customers and visitors wear face masks in the store
- Employees behind a physical barrier or in a stock or storage room or office may remove her/his mask
- **Masks may be removed if reasonably required to receive services by store (i.e. ID and age verification for age-restricted products)**
- Post signage; click [here to download signage](#)
- Obligated to inform customers or visitors that they must wear a face mask to enter store; staff can tell customers and visitors they are not permitted to enter without a face mask
- If unmasked customers enter without store consent, the store can call 311 to report the issue

Fines:

- Individuals and businesses not adhering to the by-law may be fined between \$500 to \$100,000 for each offence

CALEDON

Effective July 10th

Requirements:

- Create a policy to ensure no customer or visitor is permitted to enter without a mask; this policy must be provided to an inspector or officer upon request; policy template may be found [here](#).
- Communicate policy to staff and customers
- Train staff on the policy and who is exempt
- Ensure that customers and visitors wear face masks in the store
- Employees behind a physical barrier or in a stock or storage room or office may remove her/his mask
- **Masks may be removed if reasonably required to receive services by store (i.e. ID and age verification for age-restricted products)**
- Post signage; signage may be downloaded as part of policy template [here](#).
- Obligated to inform customers or visitors that they must wear a face mask to enter store; staff can tell customers and visitors they are not permitted to enter without a face mask

Fines:

- Individuals and businesses not adhering to the by-law may be fined between \$500 to \$100,000 for each offence

CORNWALL

Effective July 7th

Requirements:

- Adopt policy to ensure no customer or visitor is permitted to enter without a mask
- Enact and enforce policy in good faith
- Signage at front of store to indicate that masks must be worn. Signage must include specific text – review [public health directives](#) for exact wording
- Employees to provide a verbal reminder to customers or guests to wear a mask
- Face shields are not alternatives to face masks
- Employees within or behind a physical barrier (i.e. plexiglass) may remove her/his mask
- **Masks may be removed if reasonably required to receive services by store (i.e. ID and age verification for age-restricted products)**
- Upon request by a Public Health Inspector, the retailer must be able to provide a copy of the mandatory mask policy

Fines:

- At this time, no fines associated with these instructions

DURHAM REGION

Effective July 10th

Requirements:

- Best efforts should be made to only allow customers who are wearing masks into the store
- Face shields are not alternatives to face masks
- Post appropriate visible signage indicating non-medical masks or face coverings are required inside the store
- Staff may verbally remind customers to wear masks
- No need to turn away customers not wearing masks, however fines may be issued

Fines:

- Between \$750 and \$1,000 for an individual to a maximum of \$100,000
- In the case of a corporation, not more than \$10,000,000 for each day or part of each day on which the offence occurs or continues

HALIBURTON COUNTY, CITY OF KAWARTHA, NORTHUMBERLAND COUNTY

Effective July 13th

Requirements:

- Make best efforts to only allow entry to customers and visitors wearing face masks
- Staff must verbally remind customers to wear masks
- Post appropriate visible signage indicating non-medical masks or face coverings are required inside the store
- Masks must be worn inside the store at all times but **may be removed if reasonably required to temporarily remove the mask to received servicers by store (i.e. ID and age verification for age-restricted products)**
- Staff may verbally remind customers to wear masks
- Face shields are not alternatives to face masks
- Fines may be issued for non-compliance

Fines:

- Between \$750 and \$1,000 for an individual to a maximum of \$100,000
- In the case of a corporation, not more than \$10,000,000 for each day or part of each day on which the offence occurs or

HALTON REGION: BURLINGTON, OAKVILLE, MILTON, AND HALTON HILLS

Effective July 22nd

Requirements:

- Adopt a policy to ensure that customers, visitors, and staff is permitted entry to the store or remain in the store without a face mask.
- Be able to provide a copy of the policy for inspection
- Staff are trained on policy
- **Mask may be removed if reasonably required to temporarily remove the mask to received servicers by store (i.e. ID and age verification for age-restricted products)**
- Post appropriate visible signage indicating face coverings are required inside the store and text as laid out in the [By-Law here](#), pages 3 and 4. Posters can be downloaded [here](#) and [here](#).

Fines:

- As of July 20th, no fines are associated with the by-law

HAMILTON

Effective July 20th

Requirements:

- Post signage containing wording outlined in the By-Law. Sample poster can be downloaded [here](#).
- Take reasonable steps to ensure that customers and visitors are not permitted entry to or remain in the store if not wearing a face mask
- Staff shall ensure that customers and visitors that do not comply are promptly asked to leave the store
- Stores are not required to provide masks to customers and visitors

Fines:

- Every person who contravenes the by-law may be issued a penalty to a maximum of \$500.

HASTINGS PRINCE EDWARD

Effective July 7th

Requirements:

- Create a policy indicating how operators will handle various situations
- Staff trained on policy
- Post appropriate signage. Sample signage can be downloaded [here](#).
- Ensure that customers wear masks in store and make best efforts to turn away customers not wearing masks
- Employees behind a physical barrier (i.e. plexiglass) are not required to wear a mask
- Face shields are not alternatives to face masks

Fines:

- For an individual: \$750 to \$1,000 to a maximum of \$100,000
- Corporation: not more than \$10,000,000 for each day or part of each day on which the offence occurs or continues

KINGSTON, FRONTENAC, LENNOX, and ADDINGTON

Effective June 26th

Requirements:

- Retailers must ensure that customers wear masks
- Retailers are required to turn away customers not wearing masks
- **Masks may be removed if reasonably required to receive services by store (i.e. ID and age verification for age-restricted products)**
- Face shields are not alternatives to face masks
- Post appropriate visible signage indicating non-medical masks or face coverings are required inside the store
- Staff may verbally remind customers to wear masks
- Hand sanitizer at entrances
- Fines may be issued for non-compliance

LEEDS-GRENVILLE and LANARK

Effective July 7th

Requirements:

- Adopt policy to ensure no customer or visitor is permitted to enter without a mask
- Enact and enforce policy in good faith
- Signage at front of store to indicate that masks must be worn. Signage must include specific text – review [public health instructions](#) for exact wording
- Employees to provide a verbal reminder to customers or guests to wear a mask
- Face shields are not alternatives to face masks
- Employees within or behind a physical barrier (i.e. plexiglass) may remove her/his mask
- **Masks may be removed if reasonably required to receive services by store (i.e. ID and age verification for age-restricted products)**
- Upon request by a Public Health Inspector, the retailer must be able to provide a copy of the mandatory mask policy

- At this time, no fines associated with these instructions

MIDDLESEX-LONDON

Effective July 18th

Requirements:

- Take reasonable measures to ensure all persons who enter or remain in store wears a face mask
- **Masks may be removed if reasonably required to receive services by store (i.e. ID and age verification for age-restricted products)**
- Enforcement should be enacted in good faith
- Provide hand sanitizer at all entrances
- Post signage with wording noted in by-law [here](#).

Fines:

- At this time, no fines associated with these instructions

MISSISSAUGA

Effective July 10th

Requirements:

- Create a policy to ensure no customer or visitor is permitted to enter without a mask; this policy must be provided to an inspector or officer upon request
- Communicate policy to staff and customers
- Train staff on the policy and who is exempt
- Ensure that customers and visitors wear face masks in the store
- Employees behind a physical barrier or in a stock or storage room or office may remove her/his mask
- **Masks may be removed if reasonably required to receive services by store (i.e. ID and age verification for age-restricted products)**
- Post signage; click [here to download signage](#)
- Obligated to inform customers or visitors that they must wear a face mask to enter store; staff can tell customers and visitors they are not permitted to enter without a face mask
- If unmasked customers enter without store consent, the store can call 311 to report the issue

Fines:

- Individuals and businesses not adhering to the by-law may be fined between \$500 to \$100,000 for each offence

NIAGARA REGION

Effective July 31st

This supersedes any earlier by-law/order adopted by municipalities in the region (ex: St. Catharine's)

Requirements:

- Create a policy that prohibits people from entering store or remaining in the store if they are not wearing a mask
- Employees behind a physical barrier (i.e. plexiglass) are not required to wear a mask
- The policy must be available for inspection by enforcement officers and should outline exemptions for temporary removal of masks
- **Customers' masks may be temporarily removed where and when necessary for the purpose of receiving store services (i.e. ID and age verification for age-restricted products)**
- Post clear and prominent signage at entry points requiring visitors and employees to wear a mask
- Have hand sanitizer at store entrances

Fines:

- Any person who contravenes any provision is liable to a fine not exceeding \$1,000

NORTHWESTERN ONTARIO (Kenora, Dryden and Fort Frances)

Effective August 17th

OTTAWA

Effective July 7th

Requirements:

- Ensure that no member of the public enters store without a mask
- Signage at front of store to indicate that masks must be worn
- Employees to provide a verbal reminder to customers or guests to wear a mask
- Face shields are not alternatives to face masks
- Employees within or behind a physical barrier (i.e. plexiglass) may remove her/his mask
- **Masks may be removed if reasonably required to receive services by store (i.e. ID and age verification for age-restricted products)**
- Upon request by a Public Health Inspector, the retailer must be able to provide a copy of the mandatory mask policy

Fines:

- No fines were stated in the health order

RENFREW COUNTY

Effective and Enforcement Date TBA, though expected Tuesday, July 14 or Wednesday, July 15

Renfrew County is planning on implementing mandatory masks rules, which is expected to begin next week.

SIMCOE COUNTY and DISTRICT OF MUSKOKA

Effective July 13th

Requirements:

- Make best efforts to only allow entry to customers and visitors wearing face masks
- Not required to refuse entry, but store is required to verbally remind customers to wear masks
- Post appropriate visible signage indicating non-medical masks or face coverings are required inside the store
- Masks must be worn inside the store at all times but **may be removed if reasonably required to temporarily remove the mask to received services by store (i.e. ID and age verification for age-restricted products)**
- Hand sanitizer at store entrance
- Face shields are not alternatives to face masks

Effective July 8th

- Have hand sanitizer at store entrances
- Post appropriate visible signage indicating non-medical masks or face coverings are required inside the store. Sample signage can found [here](#).

TORONTO

Effective July 7th

Requirements:

- Create a policy that face masks be worn by employees, customers, and visitors
- Communicate new policy to staff and customers
- Train staff on policy
- Enact best efforts that all persons (employees, customers, and visitors) wear a mask inside store
- **Customers' masks may be temporarily removed where and when necessary for the purpose of receiving store services (i.e. ID and age verification for age-restricted products)**
- Post signs at entrances reminding everyone to wear a mask. Signs must have specific wording. View the wording or download signs from the City of Toronto site [here](#)
- Face shields are not alternatives to face masks

WATERLOO

Effective July 13th

Requirements:

- Encourage customers and visitors to wear a mask, however by-law does not require owners/operators to ensure compliance
- Post signage at front of store indicating that masks should be worn. Signs must have specific wording. Exact wording can be viewed on page three of the [health order](#). Or download posters [here](#). Decals and posters may also be picked up from City Hall or township administrative offices starting July 13th

Fines:

- Up to \$1,000 for every person who does not comply
- If a retailer chooses to report a non-compliant customer, this fine will fall on to the customer
- On the flipside, if a customer reports a non-compliant store employee, the employee and/or store will be fined

WELLINGTON-DUFFERIN-GUELPH

Effective June 12th

Requirements:

- Prohibit customers who are not wearing masks from entering the store
- Face shields are not alternatives to face masks
- Post appropriate visible signage indicating non-medical masks or face coverings are required inside the store
- Hand sanitizer at entrances and exits

WINDSOR-ESSEX

Effective June 26th

Requirements:

- Best efforts should be made to only allow customers who are wearing masks into the store
- For clarity, if the store policy is to verbally remind customers to wear a mask and then admit them into the store without a mask, this is permitted – so long as a policy can be presented to Public Health Inspectors
- Face shields are not alternatives to face masks
- Post appropriate visible signage indicating non-medical masks or face coverings are required inside the store
- Staff may verbally remind customers to wear masks
- No need to turn away customers not wearing masks, however fines may be issued

- No fines were stated in the health order

YORK REGION

Effective July 17th

Requirements:

- Create a policy to prohibit people from entering the store if they are not wearing a face mask
- Communicate policy to staff and customers
- Train staff on the policy and who is exempt
- Proof is not required if someone has an exemption to not wearing a mask
- Post approved [York Region signage](#) in stores

QUEBEC

On July 13th, Quebec Premier Legault announced that **masks will be mandatory across the entire province beginning Saturday, July 18th.**

Early details of this regulation include:

- All individuals 12 years or older will need to wear a mask when entering an enclosed public space, including our stores.
- **Business owners will be responsible for applying the new regulations, i.e. denying customers who do not wear masks entry to the store. Failure to do so could result in fines, more details below.**
- If a customer does not want to comply and they are not exempt from wearing a mask, store staff must call police.
- **Customers' masks may be temporarily removed where and when necessary for the purpose of receiving store services (i.e. ID and age verification for age-restricted products).**
- Face shields and visors are not acceptable alternatives to face masks
- From August 1st, individuals who refuse to wear masks could also face fines.

Fines:

- First offence: a warning will be issued
- Second offence: \$400
- Subsequent offences: fines will double with every occurrence, up to \$6,000

BRITISH COLUMBIA

Announced on November 19th, masks are now required for everyone in all public indoor settings and workplaces throughout the province.

PROVINCE WIDE

Effective midnight Thursday, November 19th

Requirements:

- Masks will be required in all indoor public spaces There will be exceptions for very young children and for people who can't wear masks for medical reasons
- **Customers' masks may be temporarily removed where and when necessary for the purpose of receiving store services (i.e. ID and age verification for age-restricted products)**

ALBERTA

Effective December 8th, mask wearing is required in indoor public spaces province wide.

PROVINCE WIDE

Effective December 8th

It is not yet clear how the province-wide requirements affect previous municipal and regional requirements.

- As details regarding exceptions, enforcement, and fines are clarified, we will update this list.

BANFF

Everyone is required to wear a mask in all enclosed public spaces as well as outside along downtown Banff's pedestrian zone, which has been closed to vehicle use since June to allow for physical distancing.

Effective July 31st

Requirements:

- Face shields are not appropriate alternative to face masks
- Store staff behind a physical barrier or in areas not designated for public access may remove their mask
- Display signage at entrances that include language as stated in the [by-law, page 5](#)
- Hand sanitizers are all entrances
- **Customers' masks may be temporarily removed where and when necessary for the purpose of receiving store services (i.e. ID and age verification for age-restricted products)**
- More requirement details to follow

Fines:

- Failure to wear a face covering where required or failure to display prescribed signage can result in a penalty of \$150

Effective August 1st

Requirements:

- Display signage at entrances. Downloadable signage is available [here](#).
- Stores are not expected to deny services

- **Customers' masks may be temporarily removed where and when necessary for the purpose of receiving store services (i.e. ID and age verification for age-restricted products)**
- Store staff behind a physical barrier or in areas not designated for public access may remove their mask
- Face shields are considered an appropriate alternative to face masks in Canmore

Fines:

- Failure to wear a face covering or display appropriate signage can result in a penalty of \$100

EDMONTON

Effective August 1st

Requirements:

- Business owners and operators will not be responsible for enforcement
- Business owners and operators can choose whether to deny service to customers not wearing masks
- Business owners and operations may sell or provide masks if they choose to
- **Customers' masks may be temporarily removed where and when necessary for the purpose of receiving store services (i.e. ID and age verification for age-restricted products)**
- If/when more requirement details are available we will update this section

Fines:

- Failure to wear a face covering where required or failure to display prescribed signage can result in a penalty of \$100

SASKATCHEWAN

As of November 19th, mask wearing is required in indoor public spaces province wide

PROVINCE WIDE

Effective November 19th

Requirements:

- Retailers must ensure that every person not wearing a mask in the store is given a reminder
- **Customers' masks may be temporarily removed where and when necessary for the purpose of receiving store services (i.e. ID and age verification for age-restricted products)**

Fines:

- No fines have been announced with these requirements.

MANITOBA

From November 12th, masks will be mandatory in all indoor spaces in the province and essential businesses many only operate at 25% capacity.

PROVINCE WIDE

Effective November 12th

Requirements:

- Retailers must ensure that every person not wearing a mask in the store is given a reminder
- **Customers' masks may be temporarily removed where and when necessary for the purpose of receiving store services (i.e. ID and age verification for age-restricted products)**

Fines:

- Fines for breaching or failing to comply with public health or emergency orders have recently been increased to \$1,296 for individuals and \$5,000 for corporations

NEWFOUNDLAND LABRADOR

Announced on August 17th, masks will be mandatory in all indoor spaces and on public transit in Newfoundland Labrador beginning Monday, August 24th.

PROVINCE WIDE

Effective August 24th

Requirements:

- Retailers will not be responsible for enforcement but make best efforts to encourage mask wearing
- Best efforts include signage and reminding customers to wear masks in the store
- **Customers' masks may be temporarily removed where and when necessary for the purpose of receiving store services (i.e. ID and age verification for age-restricted products)**

Fines:

- Per the order, there does not appear to be any fines associated with non-compliance, however failure to comply is an offence which could result in a summary conviction.

NEW BRUNSWICK

Mask wearing in indoor and outdoor spaces is required province wide.

As of December 7, in Zone 2 (Saint John's region), mask-wearing is required in indoor and outdoor public spaces. The Moncton region (Zone 1), which was at Orange level, is [now at Yellow](#) (masks required in indoor spaces only).

PROVINCE WIDE

Requirements (from October 3rd announcement)

- Retailers expected to make best efforts, including not permitting customers not wearing a mask, asking such customers to leave, and/or contacting law enforcement to have such customers removed from the store

NOVA SCOTIA

On July 24th, Premier Stephen McNeil and Dr. Robert Strang, chief medical officer of health announced that masks will be **mandatory across the entire province beginning Friday, July 31st**.

Early details include:

- Post appropriate visible signage indicating non-medical masks or face coverings are encouraged inside the store
- Best efforts should be made to only allow customers who are wearing masks into the store
- For clarity, if the store policy is to verbally remind customers to wear a mask and then admit them into the store without a mask, this is permitted – so long as a policy can be presented to Public Health Inspectors
- Face shields and plexiglass barriers are not alternatives to face mask. Retailers may use these **in addition** to face masks

PRINCE EDWARD ISLAND

Announced on November 17th, masks will be mandatory in all indoor spaces and public transportation in Prince Edward Island. Below are early details. We will update as more information comes to us.

PROVINCE WIDE

Effective midnight Thursday, November 19th

Requirements:

- Masks will be required in all indoor public spaces (stores, retail spaces, restaurants – except when eating or drinking, sports buildings, places of worship, etc.)
- There will be exceptions for very young children and for people who can't wear masks for medical reasons
- Face shields do not replace masks
- **Customers' masks may be temporarily removed where and when necessary for the purpose of receiving store services (i.e. ID and age verification for age-restricted products)**
